

## Get It Sorted & Win: Terms & Conditions

2. Entry to the Competition constitutes acceptance of these terms and conditions. All entry instructions and prize information published by the Promoter form part of these terms and conditions.
3. The Competition is only open to individuals who:
  - (i) received a Thank You Tag with an entry form on their Recycle or Garden Vegetation Bin.
  - (ii) Enter via post, local library drop-off or [www.1coast.com.au/win](http://www.1coast.com.au/win)
  - (iii) are not employees of the Promoter, **Cleanaway Pty Ltd, Central Coast Council, or any of their related corporations or any of their agencies** associated with the Competition; ("Entrant").

computer bugs or viruses, tampering or technical failures), subject to any relevant lotteries or gaming authority regulation's, the Promoter reserves the right to cancel, terminate, modify or suspend or recommence the Competition.

17. The Promoter assumes no responsibility for:

- i. any error, omission, interruption, or delay in the operation or transmission of any communication sent to (or by) the Promoter or any Entrant whether caused by problems with communication networks or lines, computer systems, software or internet service providers, congestion on any carrier network or otherwise,
- ii. any theft, destruction or unauthorized access to, or alteration of such communications;
- iii. any problem with, or technical malfunction of, any computer system or other equipment used for the conduct of the Competition;
- iv. any incorrect or incomplete information which may be communicated in the course of the administering this Competition (whether as a result of one of the foregoing causes or otherwise);
- v. any delay in delivery, or failure of safe delivery of the Prize.
