- (iii) Consequence of non-supply - Supply of the Applicant's Personal Information is voluntary. If Council does not have this Personal Information, Council will be unable to investigate, assess and execute this Agreement and will not be able to provide the on-site waste services requested.

- (iv) Storage and Security - The Personal Information collected will be kept in Council's Information Management System in accordance with the relevant legislation. Council's address is 2 Hely Street Wyong NSW 2259. The Personal Information collected will also be held by Council's waste contractor or sub-contractor.
